ACCIDENT CLASSIFICATION

PURPOSE OF FLIGHT:

Instrument Flying Practice.

TECHNICAL OFFICER'S REPORT:

NATURE OF ACCIDENT:

Port wing tip float and strut of a/c were damaged when it struck a flare path marker buoy during a take-off on a routine instrument practice flight.

A/c was flown by 2P., F/O Game, a fully qualified first P. on type. In his report F/O Game states that he started his take-off heading to right of buoy, but lost sight of it while attempting to check a swing to port as a/c came to stop. When he regained sight of buoy he was unable to correct swing or to alter course.
