Dear Mrs. Anderson,

On behalf of the Squadron and myself may I extend sympathy on the sad loss of your son, Sgt R.A. Anderson, who was missing from operations on the night 20/21st April, 1944.

Your son was a very popular member of the Squadron and carried out his duties as Air Gunner skillfully. Has loss was keenly felt by all concerned. Nothing has been heard since take-off, however, it may be that he is a prisoner of war. Time alone can tell us this.

Please be assured that any information we may receive will be communicated to you.

May I explain that the request in the telegram notifying you of the casualty was included with the object of avoiding his chance of escape being prejudiced by undue publicity in case he was still at large. This is a precaution adopted in the case of all personnel reported as missing.

### CONFIDENTIAL NOTICE

The names of all who lose their lives or are wounded or reported missing while serving with the Royal Air Force will appear in the official casualty lists published from time to time in the press.

Any publication of the date, place, or circumstances of the casualty, and particularly any reference to the Unit concerned, might give valuable information to the enemy, and for this reason, only the name, rank, and Service number are included in the official lists.

Relatives are particularly requested, in the national interest to ensure that any notices published privately do not disclose the date, place or circumstances of the casualty, or the Unit.

The press have been asked to co-operate in ensuring that no information of value to the enemy is published.

It is my painful duty to confirm the telegram recently received by you which informed you that your son, Sergeant Robert Allan Anderson, is reported missing on Active Service.

Advice has been received from the Royal Canadian Air Force Casualties Officer, Overseas, that your son was a member of the crew of an aircraft which failed to return to its base after air operations over Lens, south west of Lille, France, on the night of April 20th and the early morning of April 21st, 1944. This is just a note to let you know that Bob's friends over here are thinking of you all during these awful days of anxiety and uncertainty. We are all hoping that word may soon come through that he is safe.

Bob had become very popular with the lads in the Squadron, and had the confidence of the other members of his crew. He knew his job, and was always ready to give it the best he knew. His crew were a good bunch of lads, always eager to get at the job for which they had trained so long. I was chatting with them before take-off the night of their last trip, and can assure you that they were in good spirits, and ready to be off. Just what happened is not known as yet.

Unfortunately, there is no time limit within which we should get word of them, but I assure you that everything possible is done to obtain information. In the meantime, we must refuse to give up hope.

I realise that no words can lighten your heartache, but I must let you know that we are remembering you all. We pray that God will watch over Bob and the other lads in his crew, and that you may receive faith and courage and strength to carry on. Bob's comrades here are carrying on with a grim determination to keep faith with him and you and so many others who are enduring so much in these days.

If I can be of any service, please let me know.

### Notes for Information of the Next-of-Kin of Prisoners of War.

- 1. As soon as an Officer or Airman is declared to be a prisoner of war, the Department of National War Services, Ottawa forwards to the hext-of-kin detailed information and instructions regarding the despatch of letters and parcels. All enquiries should be addressed to that Department.
- 2. The Enquiry Bureau, at Ottawa, of the Canadian Red Cross advises the next-of-kin of the services it renders prisoners of war and suggests to them that if they have any difficulty in connection with the quarterly parcels or in addressing the prisoner of war in the right way, or need any other help they should get in touch with the nearest branch of the Red Cross.
- Prisoners of War Relatives Association is another organization rendering good service to prisoners of war and next-of-kin. It has its head-quarters at 130A Sun Life Building, Montreal where a Monthly News Sheet containing matters of interest to Relatives of prisoners of war is published.
- 4. Prisoners of war may have their personal effects sent to their nextof-kin, relative or friend by writing to Overseas Headquarters of the R.C.A.F., giving them the necessary instructions.
- The general policy governing the promotion of R.C.A.F., prisoners of war is that they will receive everything that they are eligible and recommended for, up to and including the date of capture or internment. After that date they will be eligible for one step ONLY in rank.
- A prisoner of war may make a continous assignment to any person or persons subject to a reserve sufficient to offset such payments as may be made to him by the detaining power and in the case of airmen, a small administrative reserve will be withheld monthly and accumulated in his Pay Account and he may give instructions to remit amounts of accumulated balances standing at his credit in his Pay Account, by addressing a letter to the R.C.A.F. Headquarters Overseas, giving the following particulars:
  - (a) Number.

(b) Full name and rank.

(c) Name and full address of the person to whom the payment is to be made.

(d) Amount of remittance in Canadian Currency.

- (e) Prisoner's signature duly witnessed by the Camp Leader.
- 7. The pay and allowances of a prisoner of war will continue to be credited to his Pay Account and assignments of pay and dependent's allowance in issue at date of capture will continue to be paid. The balance standing to his credit, after deductions for assignments and for amounts to cover issues of Pay by the detaining power have been made, will be held in trust for him. (Interest will be allowed at a rate of 3% per annum.)

We have today been advised by the Department of National Defence for Air that your son Sgt. R.A. Anderson, R191468, who was previously reported missing, is now reported a prisoner of war in Germany. We have also been advised by the International Red Cross, Geneva, Switzerland, that he is being held in Stalag Luft III, Germany. His prisoner of war number has not yet been received but we wish to advise you that we have been informed letters and parcels will be delivered without this number. Accordingly, you will please find enclosed:

(a) regulations concerning communication and parcel post(b) list of firms permitted to send tobacco and cigarettes

(c) list of firms permitted to send books, games, music, sports equipment, etc.

(d) an official label

(e) two copies of P/W No. 3, both of which must be completed and enclosed in your parcel

(f) special purchase permits for tea, coffee and sugar

You will note that the official next of kin only may send personal parcels and this once every three months. However, cigarettes, books, etc. may be sent at any time by anyone through the licensed dealers.

When you have mailed your parcel please return the enclosed card and your next label will go forward to you about ten days prior to September 7th.
